Policies and Procedures

REGISTRATION

Registrations paid in full are handled on a first come, first served basis. Registrations can be made via credit card (Visa, MasterCard), check (payable to MCDHHS), and cash. We accept registrations by U.S. Postal mail, over the phone, in person, and scanned requests sent via email. Many classes fill up quickly, so early registration is best. Registration closes one week prior to the conference.

SESSIONS BEGIN AND END ON TIME

All conference sessions begin promptly. We highly encourage you to plan your arrival to the conference at least 30 minutes early to allow for unforeseen circumstances such as traffic. Even with the best planning, we understand that late arrivals may happen. An attendee is considered late if they arrive more than 20 minutes after the keynote has begun. Just as conference begins on time, they also end on time. To ensure your prompt pick-up, make sure that any carpools, taxis, and other modes of transportation are secured prior to class beginning.

PARKING

The venue has free parking, located behind the building.

CORE OF KNOWLEDGE CREDIT

This conference has been approved for 6 hours of Core of Knowledge (COK) Training and 1 Professional Activity Unit (PAU). It also includes speakers and vendors who are available during breaks. COK certificates and PAUs count towards both licensing and Maryland Child Care Credential training requirements set forth by OCC. Participants must remain at the conference until it is completed. If you leave early and miss the assessment, we cannot issue a conference certificate.

CANCELATIONS/REFUNDS/CREDITS

There are no refunds for a missed conference or late arrivals. Cancellations via email or phone (*leave a message, if necessary*) must be made no less than **one week** before the conference. If you arrive after the registration table has closed, it will be considered a missed conference. In the event a participant wishes to cancel their registration for the conference, a refund or credit for future classes with MCCCRRRC will be issued. Cancellations must be received **at least one week before a conference** is scheduled to qualify for a refund or credit. A \$10 cancellation fee will be deducted if a refund is requested. If the student requests that a credit be issued for future classes at MCCCRRRC, the cancellation fee does not apply. Missed classes will not be refunded or credited (*including late arrivals or leaving early*).

DUPLICATE CERTIFICATES

All certificates are given at the conference. Please note, in compliance with MSDE Office of Credentialing, certificates may no longer be emailed. If you request a duplicate conference certificate, there is a \$10 administrative fee for issuing.

CONFERENCE CANCELCATION

Conferences and speakers are planned months in advance, however there are times when a speaker cancels. MCCCRRRC will make every attempt to replace the speaker. All professional development opportunities are canceled if Montgomery County Public Schools are closed due to inclement weather or other emergency. A conference may also be canceled due to low enrollment or for other administrative reasons. You will be notified by email if a conference is canceled. You may also call 240-777-3203 to determine the status of a conference. In the event, we cancel a conference a full refund will be issued, no attempts to reschedule will be made.
